-Property taxes are due to be paid in full by March 31, 2023. -Residents can request a payment plan prior to March 31 which must result in a zero balance by October 31, 2023. -Residents on a low income that are approved for a tax deduction will not be charged interest before June 30, 2023. -Residents should refer to the Town's "Residential Tax Collection Policy and Procedures" for more information.
