- 3. The sports court shall:
  - a. be setback a minimum of 3 metres from property boundaries,
  - b. not be constructed, located or placed on an easement,
  - c. not be constructed or placed over a septic tank disposal field, and
  - d. not be enclosed or have a roof.
- 4. The applicant shall submit a drainage plan for approval of Council that ensures that any water from the structure does not drain onto the adjacent property
- 5. Privacy fencing shall be required along the eastern side yard.
- 6. All other standard conditions of the permit apply. In favour 6. Carried.
