  Regulations, Section 5.4.1e provides Council with the flexibility to approve an accessory building location in front of the main dwelling in certain cases. A public notice for Discretionary Use for this application was sent out and no commentary was received. The rear yard is in the flood risk zone and the property elevation is not conducive to allowing an accessory building to be located here. Additionally, the property elevation is lower than the road and the proposed location of the accessory building is behind many tall trees, such that it would not be visible for vehicles or pedestrians passing by. Resolved that Council issue a Building and Development Permit for construction of a Detached Garage based on the information provided above. In favour 7. Carried.
